“How can I give a gift to my godchild in the Philippines?”



The holiday season is upon us and you would like to give a gift to your godchild? Christmas is a very important celebration in the Philippines, and your godchild will be delighted to receive a present from you on this special occasion. This will allow you not only to give them a gift, but also to help them and their family to spend a joyful and merry Christmas! Your support and these little marks of affection are very much appreciated by the children.



### I GIVE A CHRISTMAS GIFT TO MY GODCHILD

The best solution remains sending money since this option allows buying at lower cost: Filipino prices are widely inferior to European prices, and you do not have to pay for the shipping costs. By doing so you also contribute to the development of the local economy, and the child can choose a gift they are fond of themselves. Please note that **the total amount of your donations and gifts will be included in the tax receipt** we send you every year in March.

#### Check payment:

To give a Christmas gift, I send a check payable to CAMELEON, specifying my godchild's name and that it is a gift. Your cash donation is to be sent to the following address and we will forward it to the Philippines:

#### Bank transfer:

### A MAXIMUM AMOUNT OF 30 EUROS



We advise you to give between 10 and **30 € maximum**: considering the local standard of living, it allows you to give a beautiful gift! Be aware that the General Assembly voted to cap cash donations profiting directly to the beneficiaries at 30 €, and to regard the difference as a donation profiting the other actions of the organization. It was also decided during the last General Assembly that 20 % of the total amount of the donation will be dedicated to processing fees, and to issuing reports to sponsors.

### A LETTER AND A PICTURE



We will confirm the good reception of your cash donation by email. Then, the organization will notify the local team of the available amount, and a social worker will accompany your godchild while choosing their gift. In the following months, you will receive **a letter from you godchild along with a picture of the purchases** made possible thanks to your gift.
